CONSENT TO TERMS AND CONDITIONS FOR PROCESSING PERSONAL DATA THROUGH ACT DIGITAL SYSTEMS

By submitting a physical application or an online application through the mis.act.ac.rw/apply portal of the Africa College of Theology (ACT), you agree to the following terms and conditions regarding the collection, use, and processing of your personal data of all formats in accordance with Rwanda Law No. 058/2021 Relating to the Protection of Personal Data and Privacy and guidance from the National Cyber Security Authority.

1. Personal Information

- Applicants must provide accurate, complete, and truthful information during the application process.
- ACT reserves the right to verify the authenticity of the information and supporting documents submitted.
- Providing false or misleading information may lead to rejection of the application or cancellation of admission.

2. Lawful Basis and Purpose of Data Processing

Personal data submitted through the application portal or physically will be collected and processed for legitimate and lawful purposes, including:

- Processing admission applications
- Verifying academic credentials and identity
- Communicating with applicants regarding admission decisions
- Maintaining academic and administrative records
- Complying with legal and regulatory obligations.

Data processing will be carried out in accordance with the requirements of Rwanda's data protection legislation.

3. Data Sharing

Your personal data may be shared with relevant ACT academic departments, administrative offices, partner institutions, accreditation bodies, or regulatory authorities, where necessary for:

- Application processing and admission decisions
- Verification of qualifications and identity
- Compliance with legal or regulatory requirements.

Any such sharing will be limited to what is necessary for the stated purposes and will comply with applicable data protection laws.

4. Data Protection and Security

- ACT is committed to protecting personal data against unauthorized access, loss, misuse, or disclosure.
- Appropriate administrative, technical, and organizational safeguards are implemented to ensure the confidentiality, integrity, and security of personal data in accordance with Rwanda's data protection framework.

5. Data Retention

Personal data and application records will be retained only for the period necessary to fulfil the purposes for which the data was collected, including admission processing, academic record keeping, and compliance with legal or institutional obligations.

- Once the retention period expires, data will be securely archived or deleted in accordance with institutional data management policies.

6. Rights of the Data Subject

Under Rwanda's personal data protection law, applicants have the right to:

- Request access to their personal data held by ACT
- Request correction of inaccurate or incomplete data
- Request deletion or restriction of processing where legally applicable
- Object to certain types of data processing
- Lodge a complaint with the relevant supervisory authority if they believe their data protection rights have been violated.

7. Withdrawal of Consent

Where processing is based on consent, applicants may withdraw their consent at any time by contacting ACT.

- However, withdrawal of consent may affect ACT's ability to process the application or provide admission-related services.

8. Changes to Terms and Conditions

- ACT reserves the right to modify or update these Terms and Conditions when necessary to comply with institutional policies or applicable laws.
